ABSTRACT:

THIS WORK ATTEMPTS TO CRITICALLY LOOK INTO THE VIOLENT AND RECURRENT COUP D'ETAT DISCOURSE WHICH CIRCULATES IN A TRIVIAL FASHION IN BRAZIL AT PRESENT. THE QUESTION ADDRESSED IS WHETHER THE HISTORICALLY LOW SUPPORT FOR REPRESENTATIVE DEMOCRACY AS A FORM OF GOVERNMENT AND THE LACK OF FAITH IN THE DEMOCRATIC GAME'S PILLARS AND THE CONSTITUTIONAL ORDER ARE ANYWAY RELATED TO A NATION'S ANTIDEMOCRATIC DISPOSITION. WE CONCLUDE THAT IN REALITY THERE IS LESS OF A FASCINATION WITH AUTHORITARIANISM AND MORE OF A CONTEXT OF PROFOUND DISCONNECTION BETWEEN ELECTORS AND THEIR REPRESENTATIVES IN A STATE THAT MAKES THE EXERCISE OF CITIZENSHIP A PLIGHT UNDER THE HOMELESSNESS OF FEAR, EXACERBATED BY A CONTEXT OF CHRONIC ILLITERACY, WHICH CORRODES ANY ATTEMPT TO GENERATE A POLITICAL CULTURE THAT MAY DRIVE OUT THE BELIEF IN STAND-BY NATION SAVIOURS AND CAUDILLOS ALIKE AND INSTALL A SUSTAINABLE FAITH IN THE INSTITUTIONS AND IN THE POLITICAL POWERS OF THE STATE AS DREAMT IN THE PREAMBLE OF THE FEDERAL CONSTITUTION. WE STATE THAT CURRENT EXPECTATIONS THAT THE JUDICIARY BRANCH WILL PROVIDE REMEDIES TO THE ABYSMAL INSTITUTIONAL CRISIS MAY LEAD TO ADDITIONAL DISAPPOINTMENTS, PROMOTING A GRAVER DETERIORATION IN THE BROADER CONTEXT OF DISCONNECTION BETWEEN THE POPULATION AND THE POLITICAL FORCES, AND ULTIMATELY THE INSTITUTIONAL BREAKDOWN OF THE STATE.

ABSTRACT

THIS WORK ANALYSES THE CLASSIC LIMITS SURROUNDING THE CONTROL OF THE ADMINISTRATIVE ACT LATO SENSU, WHICH ARE USUALLY ENTANGLED IN AN ANACHRONISTIC DEBATE IN THE ERA OF POST-TRUTH, A RESULT OF WHAT WE SEE AS A MONTESQUIAN OBSESSION WHICH CONTINUES TO IMPOSE A CONCEPT OF CHECKS AND BALANCES THAT WAS USEFUL FOR A REVOLUTIONARY FRANCE BUT OF LITTLE USE IN THE CONTEXT OF MODERN CONSTITUTIONAL STATES. THE ADMINISTRATIVE ACT CONTROL IS VIEWED AS A FOUNDATION FOR SOCIAL JUSTICE AND THE UPKEEP OF THE PILLARS OF THE CONSTITUTIONAL RULE OF LAW ESTATE'S PILLAR. WE MAINTAIN THAT THE SO-CALLED JUDICIAL ACTIVISM IS IN REALITY A CONSEQUENCE OF A CITIZEN ACTIVISM, A RESULT OF OUR CONSTITUTIONAL CHOICES. WE CONCLUDE THAT THE JUDICIAL, ADMINISTRATIVE OR LEGISLATIVE CONTROL OF THE ADMINISTRATIVE ACT SHOULD BE CONSTRAINED BY THE EXACT MAGNITUDE OF THE THREAT THAT ITS EXCESS POSES.
